

UK ↔ EU ferry travel documents & border checklist (2026)

Last updated: 13 February 2026

Disclaimer: This checklist is meant to help you prepare for a smoother ferry crossing - not to replace official advice. Requirements can change, and checks vary by route, port and nationality. Always verify with official sources and your ferry operator.

Quick checklist (60 seconds)

- **Passport** valid and compliant with destination rules (issue date + remaining validity).
- If travelling **to the UK**: check if you need a **UK ETA**; apply early (each traveller needs their own).
- If travelling **to the EU/Schengen**: check the **90/180** short-stay rule (use the official calculator if unsure).
- Car travellers: bring **V5C** (or **VE103** if hired/leased, where relevant) + insurance/breakdown details.
- Pets: microchip + rabies + **Animal Health Certificate** (timing matters).
- Pack a **car-deck grab bag** (meds, chargers, snacks, kids' essentials) - you may not access the vehicle mid-crossing.

Avoid unnecessary fees (third-party ETA/visa assistance sites)

Many third-party websites offer to submit an ETA/visa application on your behalf and charge an extra **service fee**. That convenience is optional - in most cases you can apply directly for the **official price** using the authority links below.

- For a UK ETA, use **GOV.UK** or the **UK ETA app**. Third-party sites may charge more because they add a service fee - and they **cannot** get a faster decision.
- Check the web address carefully (official UK pages use **gov.uk**; EU pages often use **europa.eu** or **ec.europa.eu**).
- For pet vaccines and Animal Health Certificates, use a **registered vet** and follow GOV.UK guidance.
- If you think you used an **outright scam/phishing** site (or entered details on a suspicious domain), report it and change passwords.

Printable checklist (copy/paste)

Use this as a 'save on phone' list. Tick items the day before you sail.

DOCUMENTS

- ☐ Passport valid + meets destination rules (issue date / remaining validity)
- ☐ UK-bound: ETA checked/applied (if required) + passport used in the application
- ☐ Travel insurance details saved offline
- ☐ Booking confirmation + check-in closing time saved offline

DRIVING / VEHICLE

- ☐ Driving licence
- ☐ V5C log book (or VE103 if hired/leased, where required)
- ☐ Insurance + breakdown cover for abroad confirmed
- ☐ UK identifier on car (sticker or UK on plate)
- ☐ Basic kit (varies): hi-vis, warning triangle, headlamp converters (as needed)
- ☐ Any low-emission zone permits/stickers for destination cities

PETS (DOG/CAT/FERRET)

- ☐ Microchip
- ☐ Rabies vaccination (allow enough time before travel)
- ☐ Animal Health Certificate issued within the valid window
- ☐ Tapeworm treatment if required (dogs)
- ☐ Return-to-GB rules checked

ONBOARD 'GRAB BAG'

- ☐ Meds + essentials (you may not access the car mid-crossing)
- ☐ Chargers / power bank
- ☐ Warm layer + snacks + kids' entertainment
- ☐ Offline maps + downloaded tickets
